1. On March 9, 2007 15,000 shares of restricted stock were granted to the reporting person. The grant vests in five equal installments as follows: - After January 1, 2008, 20% vests if the 30 day avg price of Middleby common stock is greater or equal to \$125/ share. - After January 1, 2009, 20% vests if the 30 day avg price of Middleby common stock is greater or equal to \$140/ share. - After January 1, 2010, 20% vests if the 30 day avg price of Middleby common stock is greater or equal to \$155/ share. - After January 1, 2011, 20% vests if the 30 day avg price of Middleby common stock is greater or equal to \$175/ share. - After January 1, 2012, 20% vests if the 30 day avg price of Middleby common stock is greater or equal to \$200/ share.
